Apply for Social Security Benefits

Benefits

- ☐ Retirement

You worked and paid Social Security taxes.

- ☐ Family

Your current or ex-spouse worked and paid Social Security taxes.

- ☐ Disability

You have a condition and expect it to affect your ability to work for a year or more or will result in death.

- ☐ Survivor

Your spouse or ex-spouse worked and paid Social Security taxes before they died.

- ☐ Lump-Sum Death Payment

Your spouse worked and paid Social Security taxes before they died, and you are the surviving spouse.

Supplemental Security Income

- ☐ Supplemental Security Income for Disability

You're blind or have a disability. And it's hard to pay for essentials like food, clothing, and a home.

- ☐ Supplemental Security Income for Age 65+

You're 65 or older. And it's hard to pay for essentials like food, clothing, and a home.

Medicare

Medicare Part A and Part B through Social Security, so you can make both retirement and Medicare choices and withhold any premiums from your benefit payments.

If you're under age 65, you may be eligible for Medicare if you have permanent kidney failure or if you receive Disability benefits. Supplemental Security Income (SSI) does not qualify you for Medicare on its own. Even if you receive SSI, you must meet one of the other requirements to qualify.

You can get Medicare if you have end-stage renal disease (ESRD).
